## FRAUD AND FALSE STATEMENTS IN TAX RETURN

On or about April 15, 2009, within the Eastern District of New York, the defendant JOSEPHINE BHASIN, a resident of Huntington, New York, did knowingly and willfully make and subscribe a joint United States Individual Income Tax Return, Form 1040, for calendar year 2008, which was verified by a written declaration that it was made under the penalties of perjury and which was filed with the Internal Revenue Service, which tax return the defendant JOSEPHINE BHASIN did not believe to be true and correct as to every material matter, to wit: (1) the return failed to include a Schedule B and report on Part III, Line 7a of that schedule that during 2008 she had an interest in or signature authority over financial accounts located in India at The Hongkong and Shanghai Banking Corporation Limited ("HSBC India") valued at approximately \$8.3 million; and (2) the return

reported on line 8a interest income of \$1,257.16, whereas, as the defendant then and there well knew and believed, during 2008 she had earned substantially more interest income than \$1,257.16, including approximately \$169,000 of interest income earned on certificates of deposit maintained at HSBC India.
