
**IN SUPPORT OF HIS MOTION FOR PROTECTIVE ORDER**



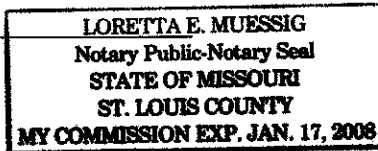
