

It appearing from the records in this action that the Court has granted Plaintiff The Society of Lloyd's ("Lloyd's") motion for summary judgment and enforced, under California's Uniform Foreign Money Judgment Recognition Act, California Code of Civil Procedure §§ 1713 et seq., a final judgment entered by the High Court of Justice, Queen's Bench Division in London, England against Defendant Samme Jo Brady;

Now, therefore, the following judgment is hereby entered:

Defendant Samme Jo Brady pay to Lloyd's the sum of United Kingdom £636,636.85 plus pre-judgment interest on that sum at the rate of 8% a year from the time the sum became due and payable on March 11, 1998, or at the option of the judgment debtor, the number of United States dollars which will purchase the UK pounds with interest due, at a bank-offered spot rate at or near the close of business on the banking day before the day of payment.
